## **BUSINESS**

The Board discussed the TV sound in The Clubhouse and Mr. Anderson read the history of this decision as follows: "At the October 19, 2017 meeting of the Board, we addressed a request from Keith Duncan to approve turning on the sound during TV athletic games shown on The Veranda. A motion to approve using sound on a trial basis on the Veranda during athletic games was made and unanimously failed 5-0.

With our new and very capable clubhouse management team in place, I recommend we revisit this board decision and entertain the idea of turning the control of TV sound back over to management to decide when TV sound is appropriate or not appropriate throughout the Clubhouse and the Veranda".

<u>Action 08.23.18-01</u>: A motion to return control of TV sound back over to management to decide when TV sound is appropriate or not appropriate throughout the Clubhouse and the Veranda was made unanimously passed 6-0.

The Board reviewed C.2 Tree Cutting Provisions. Property Owner hearings were heard for those in favor and those against the C.2 Tree Cutting Provisions.
