# **Original Narrative**

On January 12th, 2022 at approximately 1240 hours deputies were dispatched to Wilderness Parkway, McElroy Mountain Drive in Big Canoe for a person dead

Upon arrival, Deputy Gasaway spoke with Paramedic J. Reppert and Fire Fighter J. Hinds. Paramedic Reppert explained a male subject had fallen from a high position head first. Paramedic Reppert advised when they arrived on scene it was obvious the male was deceased. Paramedic Reppert explained that Jeff Mullins (deceased) was walking across the top of the structure and was attempting to get down the ladder on the right side, when he fell approximately seventeen feet head first onto the concrete floor. Paramedic Reppert was told that Mullins had a history of blacking out and that's how the fall possibly occurred. Paramedic Reppert explained that Mullins' body was originally closer to the ladder and was found in a balled up position. Paramedic Reppert told Deputy Gasaway that Mullins' body was moved from the original place of the fall in attempt to revive him from his injuries.

Deputy Gasaway and Deputy Dean were escorted into the structure where Mullins had fell. As Deputy Dean entered the structure she observed the body laying approximately three feet from where Paramedic Reppert advised it was originally lying. Deputy Dean observed blood on wood boards and the concrete floor approximately two feet from the ladder. The body was lying on its back with its arms and legs out. Possible trauma was observed along the left side of the body's chin (face) area. There were no signs of rigor mortis or lividity setting on the body. (Pictures attached to report).

Deputy Gasaway asked to speak with Mullins boss (Joey Fleming), who witnessed Mullins fall. While speaking to Fleming, he explained he knew Mullins had a history of blacking out. Fleming's statements correlated with Paramedic Repperts in reference to how the event occurred. Fleming explained Mullins was walking along a ladder which was positioned across the top of the roof. Fleming stated Mullins was stepping onto another ladder when he fell approximately seventeen feet, hitting the floor head first. Fleming explained Amanda May (who was on scene) then called 911. Fleming believed the fall could have occurred from Mullins blacking out or could have slipped and fell while trying to get down to the ladder.

Deputy Gasaway contacted CID who arrived and helped process the scene.

The County Coroner, Jerry Walker, was contacted and arrived on scene.

After the initial investigation, the scene was turned over to the coroner for the body's removal.
